Another alternative dispute technique is mediation or conciliation which is a forum in which parties can resolve their own disputes, with the help of a neutral third party. Mediation depends upon the commitment of the disputants to solve their own problems collaboratively.

Arbitration more closely resembles traditional litigation with a neutral third party hearing both sides of the story and then imposing a final and binding judgement that is enforceable by the court.
